PRIZES AND ODDS OF WINNING

PRIZE

There will be one (1) Contest winner selected who will receive the following (the "Prize"): One trip for the winner plus one (1) guest he or she decides, both of legal drinking age at the time of the entry to Cariñena, Spain.

The winner and guest will be required to provide proof of age and identity and any documentation as reasonably required by the Sponsor in order to validate their eligibility to claim the Prize. The Prize includes:

- roundtrip return standard economy flight tickets from the capital of origin of the country where the participation was made to Madrid or Barcelona Airport.
